He/she signs insurance and pension contracts himself/herself and receives claim payments and pension benefits from the insurance companies. In special situations, in case of need or changes in the business, other arrangements can be agreed between the Parties.

**The Broker** shall however represent the Client in all other matters vis-à-vis insurance companies and foundations in all other matters. He is also entitled and authorized to conduct negotiations directly in the Client's name, to inspect all files, to take over the management of existing insurance contracts and, after consultation with the Client, to terminate them and have them re-offered.

## The Broker is committed particularly to the following tasks:

- a) Review and evaluation of existing contracts, including clarifications of requirements and cost-effectiveness
- b) To advice the client for changes and new arrangements.
- c) To support the client in claims and loss situations.
- d) To inform the client about the development of the Swiss insurance market and social security requirements.

#### Compensation:

- a) Through the mandate, the Broker shall receive from the insurance companies a brokerage fee in line with the market. With the issuance of this mandate, the Client shall not incur any additional costs within the usual support obligations. If the Client's insurance company does not compensated the Broker, the Client shall owe the Broker a fee, which shall be based on the consulting effort.
- b) Additional consultations and further services shall be provided after prior consultation with the Client against payment of a fee.
- c) The Client may request from the Broker insight into the compensation of the insurance company based on his insurance portfolio at any time.

### **Contract Duration:**

The Broker Mandate is a commissioned relationship and regulated by law in OR Art. 394 ff. It starts on the date of signature, is concluded for an indefinite period and may be terminated by the Parties at any time in accordance with OR Art. 404. The right of untimely termination is reserved. The Broker shall inform the insurance companies about changes in the mandate accordingly.
